List of equipment

1. Macbook Laptop with firewire (carried by Anonym)
2. Remote Zero Midi Controller (carried by Anonym)
3. Echo firewire external audio card (carried by Anonym)
4. Mixing board with 1/4in or RCA inputs (provided by venue)

Dressing Room Requirements

Purchaser will provide a separate private dressing room, with bathroom facilities electrical outlets, and comfortable seating for 4 people near the stage. To be used by Anonym for the duration of the event.

Refreshment Requirements

Purchaser will provide refreshments for Anonym and crew (up to 4 people total) from load-in thru load-out. **At load-in:** 4 one liter bottles of non-sparkling bottled water is required at the stage. **After sound check:** catering is required in the dressing room and should consist of at least 4 one liter bottles of non sparkling water, 4 bottles of sparkling water (preferably Pellegrino), 1 bottle of good vodka, 1 one liter bottle of tonic, and 8 cans of Red Bull.

Stage Requirements

Purchaser will provide a stage protected from rain and water. Purchaser will provide electric fans, and/or heaters on stage to assure that stage temperature does not rise above 40 degrees C nor fall below 4 degrees C. If temperature exceeds either limit, Anonym will have the option to postpone, cancel, or curtail their show, with no effect to compensation. Purchaser will provide electrical outlet within one meter of table and the equipment setup. Power failure, delays in performance, and/or damage to equipment or personnel due to faulty electricity is purchaser's sole responsibility. Please note that this requirement is over and above that of any sound and/or lighting; if Anonym is providing visuals additional power will be necessary and should be coordinated with the Production Manager.

Transportation and Accommodations Requirements

1. **TRANSPORTATION / ROOMS:** If air transportation is a provision of the agreement, unless otherwise indicated, Anonym will make his own travel arrangements and upon approval will invoice purchaser for such travel. If purchaser is to provide tickets, flights must be upgradeable, and changeable without penalty. Costs will include all taxes and fees. Flights may be Coach Class, but must be upgradeable. Unless it is necessary, Anonym prefers not to fly on "red-eye" flights. All mileage points accrued will be the property of the individual flyers. All flights must be to and from locations and times convenient to Anonym. If HOTEL ROOMS are a provision of this agreement, they must be prepaid (including all taxes, required gratuities, parking, etc.), located at the venue hotel, and reserved under the name Anonym. Early check-in and/or late check out may be required. One room none smoking room for Anonym with a queen size bed. If GROUND TRANSPORTATION is a provision of this agreement, it must be air-conditioned and private, with a English speaking driver. Said transportation will meet Anonym and crew at the baggage claim for their particular flights. If for some reason, performance venue and hotel are not the same, then ground transportation must be provided between the two, at times convenient to Anonym. See contract for per diem applicability. If reimbursement for plane tickets, hotel, or ground transportation is indicated, it will be immediate upon receipt of invoice. Reimbursements and per diem are not subject to any agency commissions.
2. **ACCESS TO VENUE:** A clear access to the load-in area is required at least One (1) hour before the time the audience is to be admitted. If rented equipment is indicated, check with rental companies for required access time. Delays in starting performance due to failure to provide clear access are purchaser's sole responsibility. Lack of cooperation and nonprofessional attitudes will not be tolerated. Anonym and his accompanying personnel shall be allowed COMPLETE ACCESS to stage, backstage, and performance areas. If necessary, purchaser will provide back stage passes, badges, or other identification to allow access.
3. All terms and provisions contained herein are integral and binding parts of the Anonym Performance Agreement. All staging and equipment is to be provided, as specified. DO NOT MAKE ANY SUBSTITUTIONS WITHOUT THE EXPRESS CONSENT OF ANONYM. Should there be a disparity between the Anonym technical rider, and that of another entity (i.e. other act, venue, sound company, etc.), Anonym's rider will take precedence

GENERAL TERMS AND CONDITIONS

1. **COMPENSATION will be paid in Euros, in cash, certified or institution check, Delivered to: Anonym** in a sealed envelope immediately before performance. Agency commissions (if any) will be paid within 7 days after the event, after the balance due check has cleared.
2. Please designate one person who speaks fluent english to be a liaison between Anonym & client.
3. Please have a time schedule ready when Anonym arrives. Unless specified otherwise on the face of this agreement, Anonym's show will be 60-90 performance minutes in length. If required to perform more then 90 minutes overtime will be billed on a pro-rata basis, based on the performance fee.
4. Stage sharing: If Anonym is to share the stage with another act, DJ, etc., Anonym's equipment shall have first priority in stage position, and will not be moved without Anonym's permission.
5. Purchaser will provide adequate security for personnel, stage, back stage, and parking areas. Purchaser will not allow stage access to audience members. Purchaser is responsible for loss, or damage to equipment, personnel, or vehicles due to inadequate security, or an unruly audience. Purchaser will be responsible for any insurance coverage (liability, workers' comp. etc.) naming Anonym as additional insured.
6. The performance will not be recorded or transmitted without the prior consent of Anonym. Purchaser has the right to videotape Anonym's performance for in house use only. Purchaser will supply a copy of the unedited video to Anonym at no cost to Anonym.
7. This agreement may be rescinded by either party, without cause, by submission of written notice to the other party, not less than 30 days before performance date. If purchaser is rescinding party, deposit (or 50% of total compensation if no deposit is indicated, whether it has been paid yet or not) will be forfeited. If Anonym is rescinding party, all monies paid prior to the date of cancellation will be refunded. If purchaser cancels within 30 days of performance, FULL compensation, including any reimbursement due Anonym, will be due and payable on the date of such cancellation.
8. This agreement shall be bound by law. If an attorney is retained for the purpose of collecting compensation agreed to herein, or for any other litigation concerning Anonym and the event herein, purchaser agrees to pay for the reasonable cost of such attorney's fees.
